## INTRODUCTION

I consider it a privilege to have the opportunity to present the 28th Principal's Annual Report of the Colombo Theological Seminary, covering the period January to December 2021.

The year under review was marked, yet again, by ongoing and fresh environmental challenges that significantly impacted the work of CTS, and at the outset it will be necessary to provide a clearer picture of the context.

At the beginning of 2019, Sri Lanka was poised to move towards unprecedented economic development with market optimism at its highest since the end of the civil war ten years earlier. Tourism being one of the chief sources of revenue was poised to reach record earnings with *Lonely Planet* rating Sri Lanka as the #1 destination to visit that year.

This exuberance was to be short-lived as the devastating Easter Bombings tore at the very foundations of the nation's political stability and led to racist violence and heightened insecurity. The COVID pandemic that followed close on its heels – being tragically mismanaged for political ends – resulted in further disruption of civilian life and pushed more than a million people below the poverty line. It also meant that the country was under lockdown or had severe restrictions on movement and assembly for much of 2021 as well.

In 2021, two further disasters struck an already vulnerable populace. Both blows took place in May and both directly impacted the country's food security. On 6th May, the government inexplicably imposed a total ban on inorganic fertiliser for agricultural farming. This cut rice production (the country's staple) in half, and affected 30% of households (i.e. 6.3 million people), who are dependent on agricultural farming.

Later, on 20th May, a cargo ship laden with chemicals and plastics caught fire off the western coast. Again, with mismanagement of the disaster by maritime officials, the ship spilled 1,680 tonnes of plastic, thousands of tonnes of dangerous chemicals and large amounts of oil into the ocean. Considered the world's worst oceanic plastic-pollution incident, the capsizing of the Xpress Pearl released 75 billion plastic pellets, of which a third washed up on the country's beaches. The remaining plastic has been carried by ocean currents and will affect global marine life for decades. It also spilled 25 tonnes of nitric acid which instantly dissolved long stretches of the coral reef that was home to many species of tropical fish and other creatures and formed the natural coastal barrier. The poisoning of the ocean denied one million fisher-families their ability to make a living.

Thereafter, by August 2021, the Central Bank began to notify the public that the country was facing severe shortages in foreign currency reserves. A combination of mass-scale corruption and ill-advised economic policies, this situation would push Sri Lanka towards total bankruptcy by the end of the year. Sri Lanka has now begun to default on the repayment of her foreign debts amounting to \$51 billion. What was once a hopeful middle-income country would, in three years, be one of the world's poorest nations.

It is in such a context that the Church is called to exercise her mission: the backdrop against which Christian leadership development needs to be forged. It is our hope that the work of the seminary – both in theological life-formation and theological information – will effectively respond to the ground realities of society.

## **STUDENTS AND ACADEMIC PROGRESS**

I am pleased to report that in the year 2021 we had an enrolment of 771 students (477 in CTS-Capital and 294 in CTS-Provincial). Those currently registering in courses from around the world are incorporated within CTS-Capital or CTS-Provincial since CTS-Global (the online learning programme) is still at the development stage. In total, we offered 149 courses within the three language streams. A total of 162 students took classes for the first time at CTS-Capital alone.

It is a remarkable testimony to the grace of God and the sheer dedication of all involved, that CTS was able to continue its mission without a break in spite of the major challenges posed by the environment. Lockdowns, financial constraints, restriction on movement and in-person meetings, and the major disruption to families placed enormous stress on the whole community at CTS. Within these limitations we pressed on using our online resources and experience to ensure that courses were completed and students were assisted to fulfil requirements.

We especially thank Academic Dean Ravin Caldera for his dedicated leadership, together with the whole team of faculty and admin personnel, who lend invaluable support to our core mission. A special word of appreciation to Extensions Manager Rajaram Hariharan in recognition of his hard work to keep our provincial study centres functioning. We are also most grateful to our supporters, who extended additional financial assistance to ensure that no student was left behind on account of not being able to meet the cost of study.

### **Graduating Classes**

During the year under review, 62 students completed their programmes of study and were approved for graduation. Of them twenty-one were in the North-Central provincial centre in Anuradhapura, and 41 at CTS-Capital, centred in Colombo.

The latter had 6 Master of Arts, 22 Bachelor of Theology, 1 Diploma in Theology, 9 Advanced Certificate in Counselling, and 3 Certificate in Christian Studies. In Anuradhapura, there were 14 Diploma in Theology and 7 Certificate in Christian Studies. Due to the restriction on public gatherings, the awardees were presented their official transcripts and the graduation ceremonies were deferred to 2022.

In fulfilment of a Master of Arts degree, students are expected to fulfil course work as well as a 20,000-word dissertation (a copy of each is stored in the reference-library). The dissertations are listed below:

**Launching of the Master of Arts in Counselling (MAC)**

In September 2021, we launched a new track in our graduate studies programme. The Master of Arts in Counselling had been under discussion for some time on the initiative taken by our Course Leader: Counselling, Dileeni Abraham. A graduate-level programme in counselling recognises the great need for qualified and competent resource persons for service in the Sri Lankan Church and wider community. It aims to prepare motivated practitioners, who may also work as master-trainers equipping the Christian community to respond to the major challenges facing our society with regard to emotional- and relational- health issues.

The programme began with a course taught jointly by Dr Heather Davediuk Gingrich and Dileeni Abraham entitled 'Counselling Foundations'. The course was based on the comprehensive textbook *Skills for Effective Counselling: A Faith-Based Integration*, co-authored by the lead facilitator, Dr Davediuk Gingrich.

Dr Mano Emmanuel, as Head of Academic Advancement, provided valuable guidance in the design of the programme, and we are also grateful for the important input by Ravin Caldera (Academic Dean) and Earnest Nadeem (MA Programme Coordinator) in finalising the proposal, which was successfully implemented.

### **Developing the Children's Ministry Track**

One of the proposed aims of the Strategic Plan of 2017 was the launching of a Certificate in Children's Ministry. Towards this end, CTS initially developed a curriculum with the help of specialist input by Ms Sohani Fernando but due to COVID the work was temporarily shelved. We are pleased that, in November, we were able to welcome Christnie Edirisinghe as Coordinator: Children's Ministry Track to take the vision forward. Christnie is a BTh graduate from CTS, who studied Holistic Child Development at the Asia-Pacific Nazarene Theological Seminary (Philippines).

With Christnie's involvement, a pilot programme was planned to be conducted online - in the Sinhala and Tamil languages - and scheduled to commence in January 2022.

## **FACULTY: CHANGES AND DEVELOPMENTS**

Changes in the faculty of a seminary are inevitable but 2021 is marked by a significant number of such changes as some long-serving personnel moved on and others joined the team.

### **Changes**

**Prof G P V Somaratna (Research Professor):** In April, Prof Somaratna retired upon turning 80, after having served the seminary faithfully for nearly 24 years. In honour of his unique role, and contribution to the CTS ministry in particular and indigenous theological education in general, he has been designated 'Research Professor Emeritus' and continues to play a big part within the life of the seminary-community. Prof Somaratna joined CTS in 1997 and, alongside his teaching ministry, was responsible for producing many seminal works (especially in Sinhala) that have become standard references for the Sinhala-speaking academic and pastoral leaders of the Church. Words cannot adequately capture how grateful we are for his monumental efforts and the rich legacy he has passed on. Many faculty members – both fulltime and adjunct – testify to Professor's formative influence in their lives as academics.

**Dr Prabodith Mihindukulasuriya (Deputy Principal):** In July, we said a sad farewell to Prabo, whose time had come to migrate with his family to Canada. Prabo joined CTS as a member of the faculty from 2003, and soon became a teacher sought after by students for his cutting-edge thinking and ability to challenge them to raise their academic standards beyond expectations. His commitment to care deeply for his students and his loyalty and service to his colleagues endeared Prabo to the CTS community. Prabo excelled as a scholar and disciplined academic, and completed his PhD research and writing in record time, gaining accolades from his supervisors and the thesis committee for his quality work. In 2014, Prabo was invited to serve as Deputy Principal and fulfilled this role admirably. Although Prabo's absence from the campus is deeply felt, we are thrilled that he continues as an associate of CTS serving as Editor of the *Journal of the Colombo Theological Seminary*, and as a regular lecturer and mentor.

**Kumar Subramaniam (Spiritual Formation Coordinator):** In August, we had another sad occasion to say farewell to a much-loved faculty member. Kumar joined the faculty of CTS in 2010 after having graduated on the BTh programme. He later went on to complete the Master of Arts in Biblical Studies (CTS, 2017). Kumar gave special attention to student work and undertook the role of the Practical Training Coordinator. Along with additional training in Spiritual Formation he was invited to undertake the wider role of Spiritual Formation Coordinator in 2019. Kumar resigned to be able to take up masters-level study at the Asbury Theological Seminary in the US. His faithful service and hard work played a major part in strengthening CTS during a crucial period of its history, and we are deeply grateful for what God accomplished through his ministry.

**Rev Earnest Nadeem (MA Programme Coordinator):** Later in October, we faced another departure by a wonderful colleague, who had served as the MA Programme Coordinator since 2015. Earnest was the first student from overseas who came to CTS to study for the Bachelor of Theology. He married Maidhily Kannan (BTh alumna 2003) and moved back to Pakistan, where he was ordained and also served as a faculty member at St Thomas Theological College in Karachi. His relocation to Sri Lanka enabled him to fulfil the role of a theological teacher at CTS while serving as a priest in the Church of Ceylon's Diocese of Colombo (as Assistant Curate at the Cathedral of Christ the Living Saviour). He was a dynamic coordinator of the MA programme, and under his leadership the cohort of students grew and a number were able to complete their requirements and graduate. We thank God for his work as a teacher and for his deep loyalty to his alma mater that strengthened the development of CTS over the past six years. Being called to give his full-time attention to his parish position in Colombo, we had to sadly say farewell to Earnest and wish him well in all his future endeavours.

## Developments

**Nathanael Somanathan:** In August, Nathanael moved to the UK to commence PhD research at the University of Birmingham. His research will explore theological anthropology from the intersection between Pentecostalism and Eastern Orthodoxy for a South Asian Buddhist context, and is expected to take three years to complete. Nathanael is a young scholar, who joined CTS in 2019 and is an exceptionally astute thinker. In recognition of his potential as an emerging theologian in Asia, he was awarded scholarships by ScholarLeaders International and by Langham Partnership, which have facilitated this opportunity. We are deeply grateful to these generous partners for extending their support. We also congratulate Nathanael on his marriage to Skyler Laney on 26th July.

**Dr Ivor Poobalan:** From July 2021 to January 2022, Ivor was granted sabbatical leave towards writing projects. He had been invited as a Visiting Scholar for four months at the Asbury Theological Seminary at Wilmore, Kentucky, and alongside working on two books on *Genesis* (i.e. a devotional and a commentary for the use of theological students and pastors), Ivor participated in various activities including preaching at the Estes Chapel and conducting a seminar for faculty members and doctoral students.

**Johnson Sandrasegar:** We commend Johnson, who is currently enrolled in the Master of Social Work programme at the National Institute of Social Development (NISD), and wish him well as he works towards a successful finish.

**Dr Sanath Athukorala:** In August, Sanath was appointed Spiritual Formation Coordinator. He will simultaneously undertake responsibility to strengthen the alumni network and organise programmes for CTS' continuing ministry towards over 650 leaders, who have graduated through CTS programmes and are currently engaged in Christian service around the country.

**Bernard Costa:** In September, we were pleased to welcome Bernard to take up the role of MA Programme Coordinator and Lecturer. Bernard had, previously, been serving as a member of the visiting faculty. He studied at the International Graduate School of Leadership (Philippines) and Dallas Theological Seminary (USA), and has many years of experience in theological education, having previously served at Gospel for Asia Bible School, and at Lanka Bible College and Seminary. He is also involved in a ministry of discipleship and formation for rural pastors.

**Julian Devadason:** In October, we were also pleased to welcome Julian, who had been serving as an adjunct faculty member for many years. Julian is a Masters graduate of the Asia Center for Theological Studies and Mission (South Korea) and has many years of ministry experience, especially in teaching and mentoring leaders.



## **CHURCH-DIRECTED PROGRAMMES**

## **FINANCE AND FUNDRAISING**

A pandemic on the scale of the COVID-19 plague must surely be synonymous with financial ruin; and, it is such an effect that we braced ourselves for as the weeks dragged on into months and then into the second year. It is surely, therefore, by the gracious provision of a faithful God that CTS has been able to come through the second year of the global pandemic in a stronger financial position than when we entered it. The improvement of our balance sheet and the continuing trend of a healthy sum of income over expenditure is cause for gratitude and will be encouraging to our donors and partners everywhere. This is a result of a combination of factors including the thought-through policies by the Council, the supervision provided by our Treasurer, Rev Ramesh Schaffter, and the Admin and Finance Standing Committee, the efforts of the Accounts office, the commitment made by the team to reduce unnecessary expenditure, the reduction in expenditure due to lockdowns, and the notable unexpected increase in Christian philanthropy worldwide following the pandemic.



I take this opportunity to record our deep appreciation to Kavitha Thurairajah, who served as Accountant from May 2019 to April 2021. Her dedicated work – often times single-handedly – was exemplary and enabled us to maintain a strong and verifiable system of accounts. She was succeeded by Dinesh Thambiahpillai, who joined the team in April 2021. Dinesh has long experience working at a large not-for-profit organisation and we look forward to his leadership to take CTS finance to an even stronger position.

During the year, we also said farewell to Accounts Officer Augustin Sebastian, who had served for over 4 years.

### **Income and Expenditure**

In total CTS raised usable income amounting to Rs 66,490,034. A further sum of Rs 10,748,000 was received as compensation for the acquisition of road-front land. This latter amount has been classified as a Restricted Fund to be used for the purpose of new acquisition or development of property.

Our expenses for the year amounted to Rs 51,554,617 - which was significantly lower than the budgeted expenses. The largest single expense was towards staff costs, which is 61% of the total. In 2021, we implemented Phase 1 of a salary revision scheme spread over three years, which sought to reset the salary structure and do away with anomalies that had persisted over time. It also sought to make salaries comparably related to wages offered at other not-for-profit educational institutions in the country.

### **Donations and Fundraising**

The financial viability of not-for-profit ministries like CTS depends largely on the generosity and disciplined giving of God's people, and over the years we have been blessed to see this biblical dynamic at work.

The dedicated work by our Resource Development Manager, Rochelle Hakele-Ranasinghe, is greatly appreciated for the part she has played over the years towards increasing the donor base and building strong partnerships. Credibility and trust are fundamental to sustained giving, and it is a great joy that many donors maintain long-term commitments to the cause. We also appreciate the team of staff in the RD department who provide able support.

While we experienced a drop in pledges and donations, we saw a marked increase in funding related to extensions programmes. In total, we received new donations amounting to Rs 17.5 million.
